

Al-Ameen College of Law had organized webinar on Self Reliance on Water Availability and the Water Act 1974, on 12th November 2021, at 10:00 A.M.




## CONSTITUTION DAY CELEBRATION

In order to celebrate the 71st Anniversary Year of the adoption of the Indian Constitution by the Constituent Assembly, (72nd Constitution Day) the


Al-Ameen College of Law through its NSS Unit organized a grand programme

The Karnataka State Law University directed all the affiliated colleges to conduct the Internal Assessment (IA) Tests in online mode. In pursuance of this order, the Al-Ameen College of Law for the first time introduced the online method of conducting IA Test by developing a customized online platform. Students got the opportunity

Hi students. This online platform is for the academic assessment of the students of law (both 3 years and 5 years courses). The score you secure by attending to the tests through this platform may be used for assessing your academic level as on date. All the students must compulsorily attend to the tests and make sure that you are well prepared before taking up these tests. Each one of you will be provided with an unique login ID. Do not share your login credentials with

attempting the online tests by logging in to the College official website. A distinguished android app, ‘AACL TEST’ was also launched for smooth conducting of IA Test. The android app was made available in Google Play Store. IA Test for even semester of June/July examination were successfully conducted online through

this mode between 18-25th August 2021.

#### Salient features of AACL Test App:

- This System helps educational institutions to conduct exams to any number of candidates at a time, in an automated manner. It reduces the time consumption and workload that exist in the current system of examination. It also helps in storing the record of each examination and the results are also stored in the system. This makes the searching of the records easier.
- It is a Multiple Choice Questions (MCQ) based examination system. It provides an easy to use environment for both Test Conductors and Students appearing for
- Examination. It is a fully automated system that not only saves a lot of time but also gives fast results and saves paper. It is a cost-effective and popular means of mass evaluation system.
- The faculty prepares the tests and questions for each exam and the admin uploads the same in the software.
- The candidates can login through the android app or through the College official website with their roll number and password given to them and can take the exam.
- The questions are shuffled in a random order so that possibilities for getting questions in the same order for the students who are beside, is very less.
- The system handles all the operations and generates reports as soon as the test is completed which saves the precious time of faculties spent on reviewing answer sheets.


