ABOUT THE COMPETITION

A debate is a discussion or structured contest about an issue or a resolution. A formal debate involves two sides: “one supporting the resolution (affirmative) and one opposing it (negative)”. Such a debate is bound by the rules mentioned in the brochure. Debates may be judged in order to declare a winning side. A team consists of two to three members. When the formal debate is finished, time will be given for rebuttal. Debate proved to be a great device in engaging students and enables them to voice their valuable views. It is important because it develops skills and knowledge and provides scope for a student to become confident and bold. It is an indispensable characteristic of an individual that makes him put forward his perspective in analyzing the situation of social cause whether be it in favour or against. The AACL Mooters Society is very glad to announce Intra-Collegiate Debate Competition as to provide a good opportunity for the students to showcase their talent.

ELIGIBILITY

The competition is open for all the students of 3 Years LL.B Course and 5 Years B.A. LL.B. Course. Only individual registration is allowed and there are no restrictions in the number of registrations from the same class.

STRUCTURE

1. The competition will take place over a period of two days. On Day-1 Preliminary Round and Quarter Final will be conducted and on Day-2 Semi Final and Finals will be held. The exact time schedule will be intimated in due course of time.
2. The format of the debate will be based upon the **Lincoln-Douglas Model of Debating**.
3. The Competition will proceed in a 1 v. 1 Format.
4. Participants are encouraged to register individually. As many as students may get registered from the same class.
5. The opponents and motions for preliminary round will be decided on the basis of draw of lots a day before the rounds.
6. In the preliminary round, based on the collective scores of each team, the top 16 teams will proceed to the quarter final round. Thereafter, in each proceeding round of competition the best team from each room will proceed to the next round. In other words, quarter final and semi final round will be Nock Out rounds.
7. Motions for quarter final, semi final and final rounds will be fixed on the basis of draw of lots 30 minutes prior to the commencement of the rounds.

TIME ALLOTMENT

1. Each participant will get 5 minutes to speak and another 1 minute will be given to each participant for rebuttal in the preliminary round. The first warning will be shown at the end of three minutes, with a final warning at the end of four minutes and thirty seconds, after which the speaker must conclude the argument within last 30 seconds. After the completion of arguments from both the sides each speaker will get a chance for 1 minute rebuttal.

2. The time limit for the quarter final, semi final and final rounds shall be 10 minutes per participant and 2 minutes for the rebuttals. 1 minute extra will be given to wind up the arguments/points presented. The first warning will be shown at the end of eight minutes, with a final warning at the end of nine minutes and thirty seconds, after which the speaker must conclude the argument within last 30 seconds. After the completion of arguments from both the sides each speaker will get a chance for 2 minutes rebuttal. After the completion of rebuttals from both the sides each speaker will be given last 1 minute to wind up the arguments/points presented.

RULES AND CODE OF CONDUCT

1. The competition will be conducted in English language only.
2. The participants must attend the competition in College Uniform.
3. Reading out the speech from paper or use of any book, document, or electric gadget during the debate is not allowed. However, one can carry a short note for reference.
4. The Participants should attend the event on time, show conscientious effort in participating, and conform to the event rules and regulations. If a participant during the competition does not appear for more than 10 minutes after the scheduled commencement of the competition then that participant will be disqualified.
5. The participants must maintain professional decorum throughout the competition. The Participants are expected to be honest, behave with dignity and treat others with respect and courtesy. The behaviour of any individual should not interfere with the rights of others. This includes the use of appropriate language, actions and attire. The participants are expected not to harass others verbally. Use of unparliamentarily language/signs will lead to immediate disqualification or non- consideration of marking.
6. By registering for this competition, the participants shall be agreeing to all rules, terms, and conditions laid forth in this document and any further rules and conditions that the organizing committee of the College may lay down further.

MARKING CRITERIA

The following would be the marking criteria to judge the speaker during the competition:
