- Original research papers are welcomed on the above mentioned or any other related theme.
- The paper can be co-authored. However, a maximum of two authors per entry is allowed.
- An author is permitted to present a maximum of 1 paper only.
- The author(s) shall specify in the first page of the abstract and the full paper the below mentioned details:
 - i. Title of the Seminar
 - ii. Title of the Paper with theme
 - iii. Name (s) of Author (s)
 - iv. Designation
 - v. Name of the Organization / University / Institution
 - vi. Email address
 - vii. Contact number

It is mandatory to mention Email address, as all future correspondence will be through it only.

- The Abstract and the Full paper should be submitted in .doc/.docx format with the following specifications:
 - i. Font Type: Times New Roman
 - ii. Font size: 12
 - iii. Line spacing: 1.5
 - iv. Footnotes Font Type: Times New Roman
 - v. Footnotes Font size: 10
 - vi. Footnotes Line spacing: 1
 - vii. Margin to be of 1 inch on all sides
 - viii. Citation: Any uniform method of citation may be followed.
- Submission of Abstract: The Abstract containing full details of the Author(s) as mentioned above should be submitted through Email only.

- After receiving confirmation by the organizing committee the participant shall mail their full paper containing full details of the Author(s) as mentioned above.
- The Abstract should not exceed 250 words.
- All submissions should be within the range of 3000-5000 words (exclusive of footnotes).
- All submissions should be the original work of the author, and should not have been submitted for publication or published elsewhere in any form.
- The Rules are subject to change at the discretion of the Organizing Committee.
