## Rules & Regulations

## RAGGING IS PROHIBITED

Ragging in any form is strictly forbidden by law. The students should not be found involved in ragging. Maharashtra prohibition on Ragging Act 1999 has the following provision for action against Ragging. Ragging within or outside any educational institution is prohibited. Whosoever, directly or indirectly commits, participates in, abets or propagates ragging within or outside any educational institution shall, on conviction be punished with imprisonment for a term upto 2 years and/or penalty which may extend to ten thousand rupees. Any student convicted of an offence of ragging shall be dismissed from the educational institution for a period of five years from the date of order of such dismissal.

## UNIFORM MUST

To regulate discipline and uphold decorum, a prescribed dress code is to be observed by students, which requires that they be formally dressed while on campus. The student should compulsorily wear in college campus.

## LIBRARY RULES

The books are systematically arranged according to titles and subjects. The students are expected to follow the same during reference work. Mobile phones are strictly prohibited.

## STUDENTS PARKING OF VEHICLE

Students should park their vehicles only in the specified area.

## ANTI SOCIAL ACTIVITIES

Students should not participate in any political and antisocial activities. Strict disciplinary action shall be taken against such students.

## GENERAL RULES OF CONDUCT

- Student must abide by the rules and regulations framed by the institute from time to time.
- The student is expected to read the notices put up on the notice board of the college regularly. The college is not responsible for any loss or damage caused to the student due to his failure to read the notices from time to time.
- Any change in the residential address of the student must be communicated to the office immediately.
- Student should carry their identity card while in the college.
- Specific sets of regulations covering particular areas of the College may be posted from time to time, after being approved by the College Management Committee, and must be respected.
- Students must inform the College Office of their term-time and permanent addresses and any changes thereof.

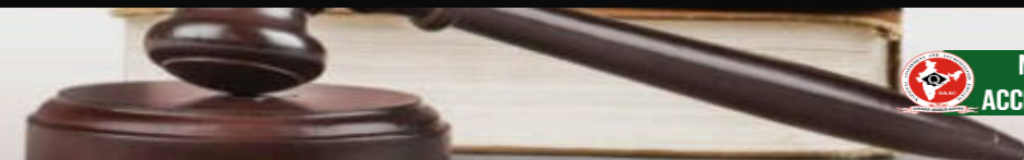

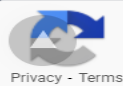

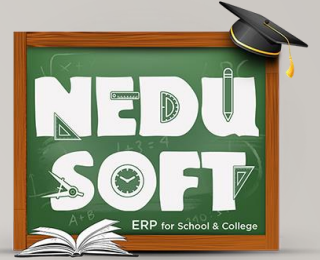
