FEED BACK ANALYSES REPORT

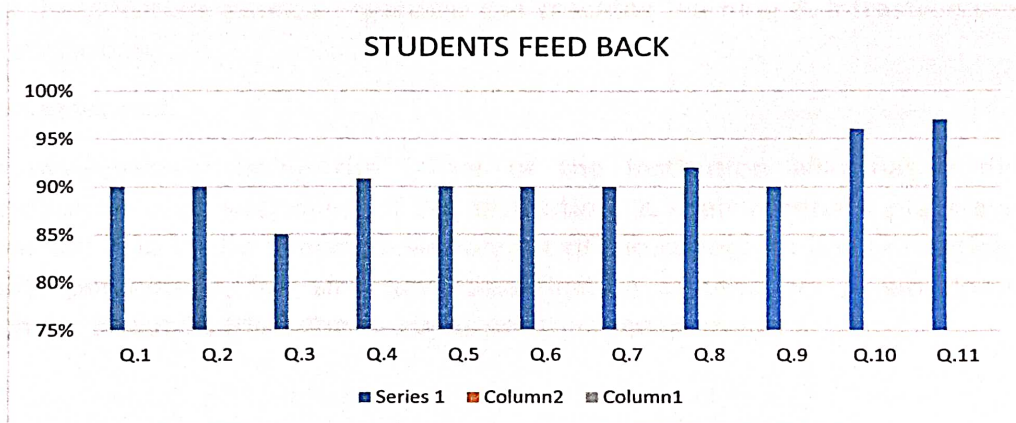

The college collects the feedback on various curriculum aspects and courses from different stakeholders such as the students, alumni, Faculty, Employers and Parents using feedback form. The feedback collected from the individuals has been analysed and taken to the consideration for the development of curriculum, teaching learning process.

The college has a proper feedback form for obtaining feedback from the stakeholders. The Students' Feedback on curriculum and teaching learning process at Al-Ameen College of Law premise is designed to get the proper feedback from students that can be used towards the improvement in the quality of course design and delivery, as well as student learning experiences. For the academic year 2022-2023, students' feedback is sought from around 550 students about the curriculum, teaching learning process. Majority of the student population agreed that the syllabus is very much authenticated and the allocation of credits is appropriate in relation to the level of course.

Through the survey, students (by combining both agree and strongly agree) agreed that teachers complete the entire syllabus in time, and 90% the curriculum & syllabus content are appropriate for the course undertaken. 90% of the students agree that the faculty adopts innovative methods & modern technology in teaching & learning. 85% students agree that modern technology in teaching & learning, 90.8% students agreed that the faculty is helpful &



Management



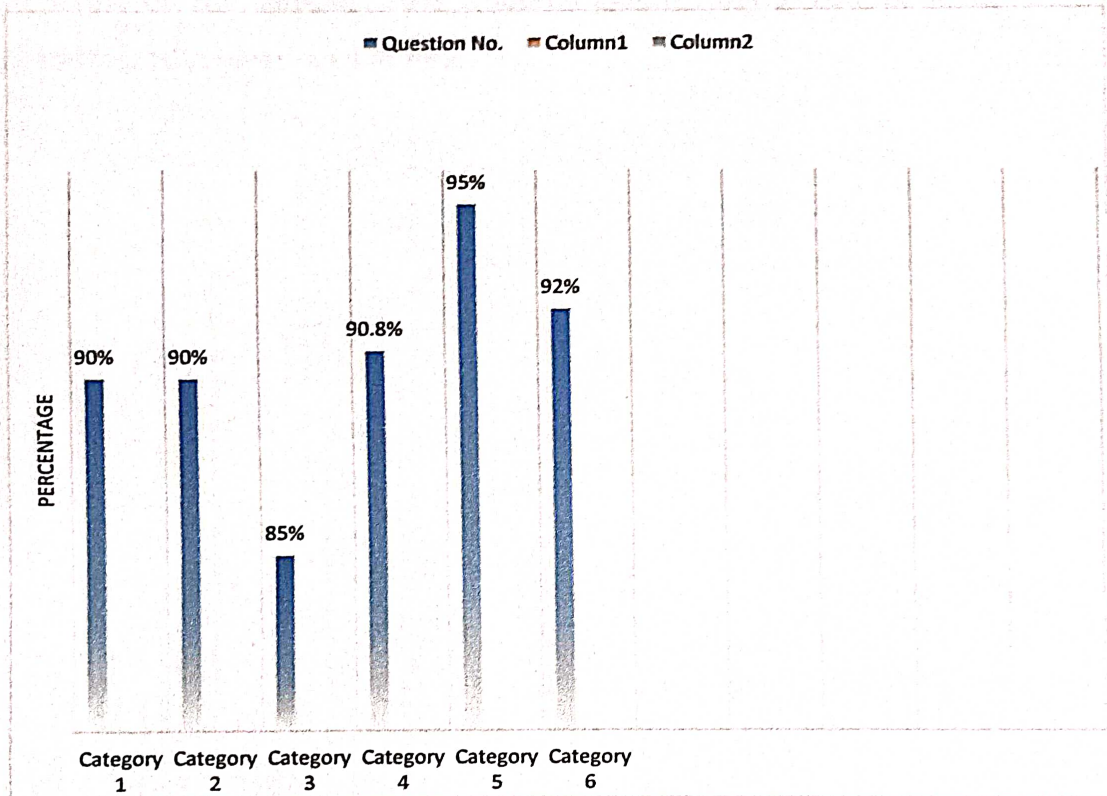
Judges




