

 - ii) Models of buildings/structures related to law like Supreme Court, High Court, Parliament, United Nations etc. made from POP or Therma coal.
 - iii) Portraits/pictures of legal personalities like Supreme Court and High Court Judges, Jurists, Lawyers etc.
 - iv) Flowcharts of various legal concepts/aspects.
 - v) Documents related to personal laws like Nikahnama etc.
 - vi) Projects related to IPR.

- vii) Any other related projects.
- 2) The project can be made by an Individual student in his own name or a group of students not exceeding three in their names.
- 3) The projects have to be submitted on or before 31st December 2022, Saturday to the coordinators.
- 4) All the projects will be displayed in the gallery on the day of exhibition i.e., on 03-01-2023.
- 5) The selected projects will be permanently kept/affixed for display in the "Al-Ameen Law" Lab" which is going to be inaugurated very shortly.

REPORT ON INAUGURATION OF LAW LAB


