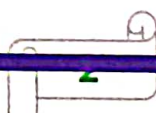

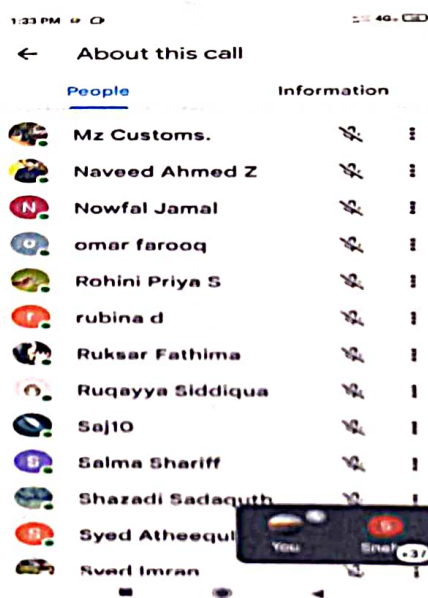
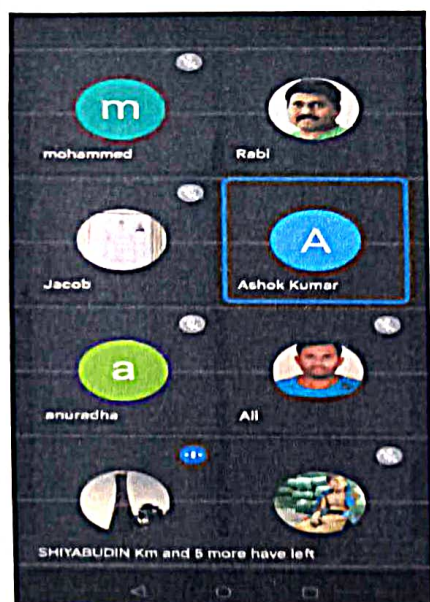

## CONSTITUTION DAY CELEBRATION

Constitution Day or Samvidhan Diwas which is commonly named as National Law Day is celebrated on November 26 every year to commemorate the adoption of the Constitution of India. The Constituent Assembly of India adopted the Constitution of India on 26 November 1949 and it was legally enforced on January 26, 1950. Almost 65 years later, the Government of India declared 26 November as Constitution Day on 19 November 2015 by a gazette

notification. It is also the day when the nation remembers Dr. B.R Ambedkar, the architect of the Indian Constitution and his fellow companions of the Drafting Committee.

In order to celebrate the 71<sup>st</sup> Anniversary Year of the adoption of the Indian Constitution by the Constituent Assembly, (72<sup>nd</sup> Constitution Day) the Al-Ameen College of Law through its NSS Unit organized a grand programme on 26-11-2020, Friday



between 10:00 a.m. - 12:30 p.m. To deliver a special lecture on this event we had with us Sri K Jayaprakash Hegde, Hon'ble Chairman, Karnataka State Commission for Backward Classes, Bangalore as the Chief Guest. Smt. Kaveri, Senior Civil Judge & Deputy Secretary, Karnataka State Legal Services Authority, Bangalore and Smt. Sheetal Varma, Advocate, Supreme Court of India were the Guests of Honour for the programme.

The event was inaugurated with remembrance of the God almighty by reciting few verses from Holy Quran by Mr. Mohammad Siddiq of I Semester 5 Years B.A., LL.B. Course. Dr. Waseem Khan M I, Principal, Al-Ameen College of Law welcomed and felicitated the guests.

The Chief Guest of the Programme Sri K Jayaprakash Hegde addressed the gathering. In his address Mr. Hegde highlighted the importance of learning law, learning Constitution and reading the Constituent Assembly Debates. He also gave an overview of the special provisions for backward classes under the Constitution and under various State laws. While concluding his speech he emphasised on getting benefitted with fundamental rights and obeying the fundamental duties.


Guest of honour of the programme Smt. Kaveri while addressing the gathering

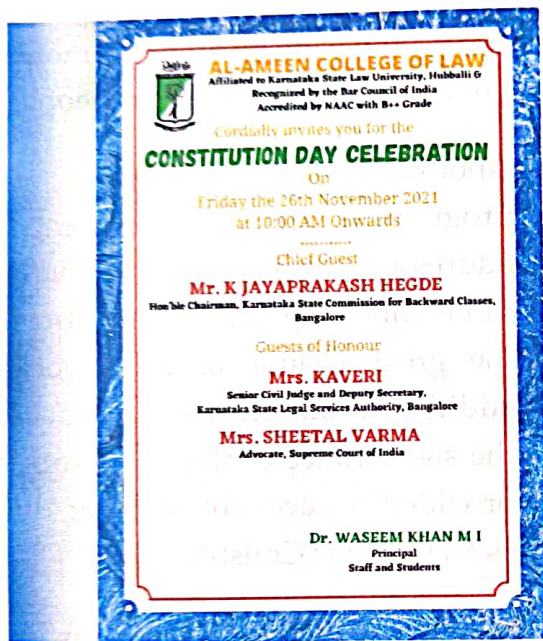

In addition to this she also commented on the significance of the Constitution and provided an account of other different aspects of our Constitution.

## FREE BLANKET DISTRIBUTION DRIVE

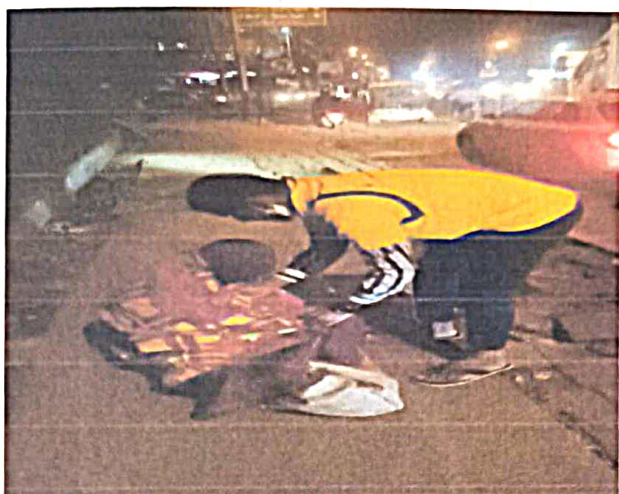


areas City Market, Kalasipalya and Avenue Road in Bangalore.

sustainable. About 50 saplings were planted in and around the college campus.

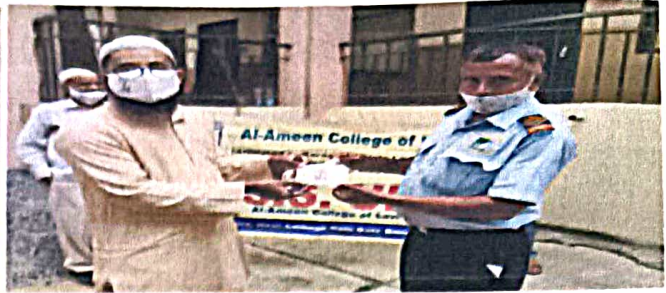


## FREE FACE MASK DISTRIBUTION

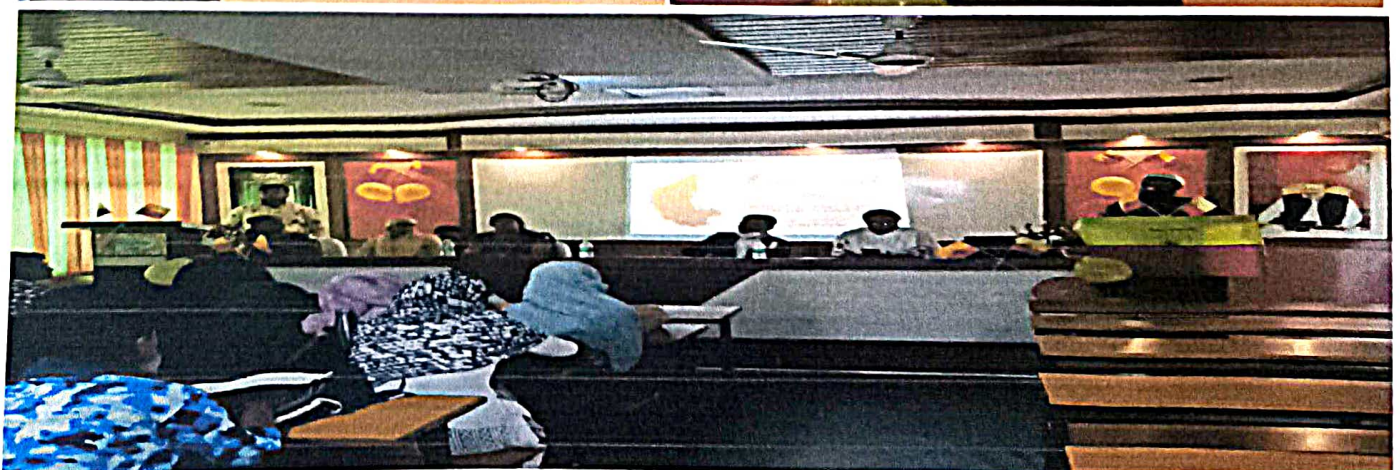




## KANNADA RAJYOTSAVA CELEBRATION
