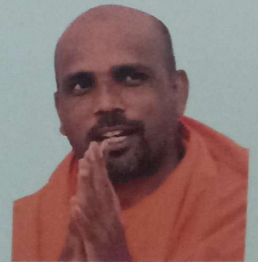

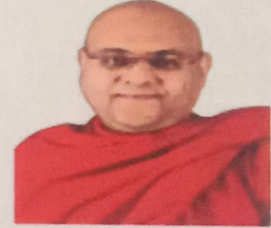

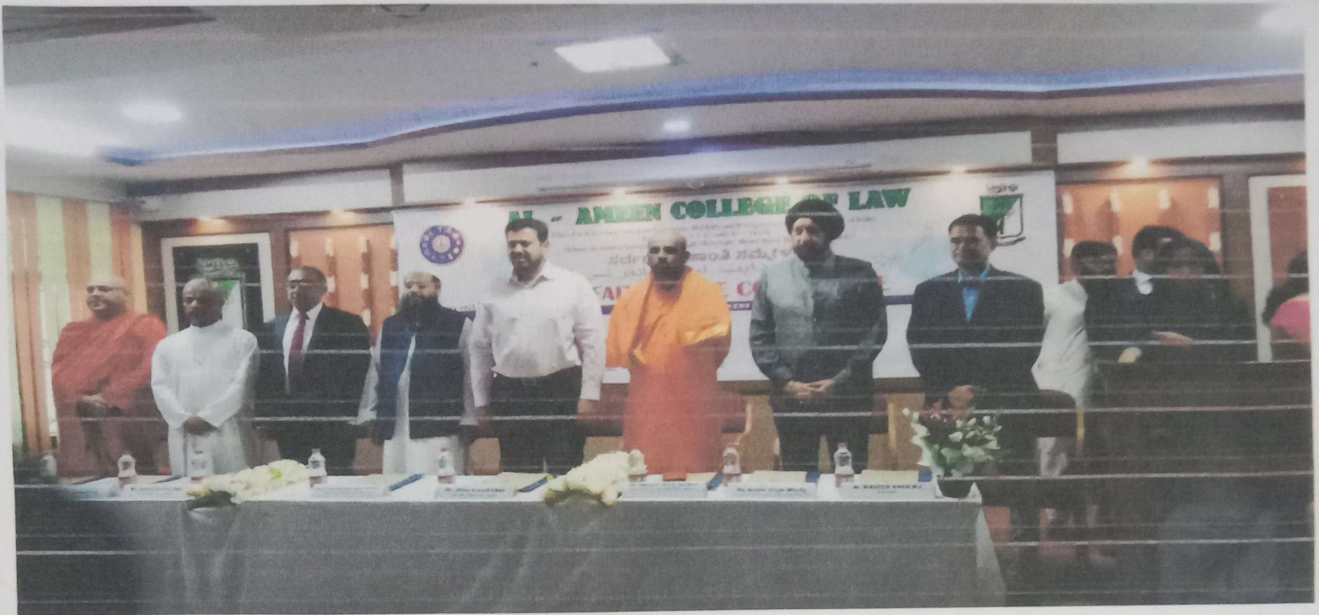
PURPOSE OF THE CONFERENCE


