

IQAC was constituted before the NAAC peer team visit in 2013. Normally 14 members were included in the IQAC team. It includes the Management Member, Principal, Vice-Principal, Senior Faculty Members, External Members, students' representation and Alumni students. IQAC encouraged the faculty to conducting seminars / conferences and workshops. FDPs were also organized to enhance the teaching skills, it also organized stress management sessions. It helps the faculty members to handle students in a better way. The Continuous Internal Assessment /Assignments tests were conducted to monitor the progress of the students. According to the University norms assignments and seminars are given to the students, based on which the internals are awarded. Based on the performances of the students remedial/ revision classes are conducted. Students' Seminar, moot courts, mock trails, debates and model assemblies, Group discussions & Quiz Programmes are conducted regularly. Project based learning, peer learning, ICT oriented teaching is used.




ANNUAL REPORT FOR THE YEAR 2022-23









LAW BOOKEXHIBITION



NATIONAL MOOT COURTS REPORTS

REPORT ON AACL NATIONAL LEVEL MOOT COURT COMPETITION

Al-Ameen College of Law is a professional undergraduate college in Bangalore, Karnataka, India. It was established in the year 1991 as a center for academic excellence achievement in the field of law. It is under the aegis of Al-Ameen Educational Society which was established in the year 1966 and one of the biggest minority education society in India. Dr. Mumtaz Ahmed Khan is the founder of Al-Ameen Educational Society. Al-Ameen College of Law is celebrating its Silver Jubilee this year, on this occasion it organized National Level Moot Court Competition from 11th -13th March 2016.

The National Level Moot Court Competition organized by AACL Mooters Society of Al-Ameen College of Law truly deserves to be called as all India Moot Court Competition as it boast the participation of 32 law colleges from all over India, from Kashmir to Kerala. Out of 32 teams 21 teams were from outside Karnataka the remaining 11 teams were within Karnataka.

The Moot Court Competition was inaugurated on 11th March 2016 by the Chief Guest, Hon'ble Justice Mr. Santosh Hegde, Former Justice of Supreme Court of India by striking the gavel. In his speech he shared his dream of corruption free India and encouraged the students to uphold the justice. The Inaugural session of the competition was presided by Dr. Mumtaz Ahmed Khan is the founder of Al-Ameen Educational Society and Mr. Subhan Shariff, Honorary Secretary Al-Ameen Educational Society. The inauguration was followed by Draw of lots and exchange of Memorials among the 32 participating colleges.

On 12th of March 2016 the preliminary round of the competition was held. After the two sessions of the preliminary round 08 teams from among the 32 teams were qualified for the Quarter-Finals held on the same day which was judged by eminent IPR advocates.
