Al-Ameen College of Law is actively engaged in community welfare services. These practices demonstrate the institution's commitment to social responsibility and making a positive impact on the community. Here's an overview of the community welfare services they provide:

- Health Checkup Camps and Distribution of Free Medicines: This initiative helps
 provide essential healthcare services to the underprivileged population who may not
 have easy access to medical facilities.
- 2. **Cleaning Drives:** Cleaning drives contribute to maintaining a clean and hygienic environment, improving the overall well-being of the community.

5. Evidence of success:

The institution every year conduct community welfare services in and around Bangalore. The college selects down trodden areas for service. The student conducts survey before conducting the programme. After perusing, the survey reports the college conducts legal literacy programmes to create awareness among the down trodden community. The feedbacks collected on the conclusion on such several legal literacy

programmes were very motivating and encouraging. The student of our institution gets enriched about the actual realities of life and the compounding problems of the society. This forces the students to think about remedial measures and accordingly become very keen observers in the proceedings of programme.

6. Problems encountered and resources required:

Every new initiative takes time to get materialized. Initially problems lie with regard to the approach which students need to adopt while conducting survey to conduct legal literacy programme. The experience of the institution over the years showed that while conducting the survey the students need to be very simple, respectful and be homely with the villagers. After giving them a confidence, the very purpose of the survey may be communicated to them with its merits. More importantly we have observed that the communication in the local language encourages them to speak.

• Sanitization in slums around the college.

AL-Ameen College of Law, who adheres to the protocol of the pandemic, took the initiative to sanitize the surrounding slums around the college through NNS united co-ordinated by NSS Coordinator, Mr Mubarak Khan, Syed Suhail & Mr Abdul .M Rawothar. On the 12th of Sep 2020, also students & staff of the institution took part in successfully caring out the programme.

During this programme the awareness about preventions & precautions of the pandemic (COVID) was been highlighted also face marks was distributed to the slum dwellers who required the most.

• Free Medical Aid to cancer patients.

Al- Ameen College of Law along with Nari Foundation an NGO associated with Narayana Hridalaya Foundation, conducted free Medical Camp & cancer screening for women specially through WOMENS CELL of the college, on the 20 March 2019, in college premises for all the women employees of Al-Ameen Educational Society, and women of the surrounding slum & locality , about 700 & odd women had undergone the test & screening , about 12 women were identified as positive for Brest Cancer who were in 4th stage , these women were treated by the Narayan Hridayala free of cost .
