Nature of Specimen

Received a muscle bit of 0.5x0.5cm, bisected and submitted.

Histopathology Report

Cryo & paraffin sections from skeletal muscle shows partially effaced architecture. Myopathic features such as hypertrophy, rounding, central nucleation & splitting is seen. There is no myophagocytosis. Several fibers show rimmed vacuoles, seen both on HE & MGT stains. Endo mysial creeping fibrosis is seen. There are no lobulated fibers.

Muscular dystrophy with rimmed vacuoles – Right biceps muscle biopsy.

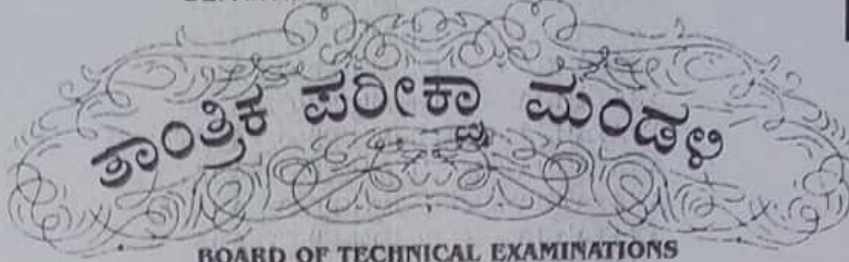
